## **Updates to National Guidance**

### School suspensions and permanent exclusions

- Guidance on <u>school suspensions and permanent exclusions</u> has been updated, coming into force from September 2023.
- The updates underpin the <u>School Discipline (Pupil Exclusions and Reviews) (Amendment and Transitional Provision) (England)</u>
   <u>Regulations 2023</u> to allow headteachers to cancel exclusions if appropriate. In addition, school governing boards' exclusion review and independent review panels will be able to take place remotely, ensuring exclusions are conducted in a lawful, reasonable and fair way.
- The DfE have also <u>published a guide for parents and carers</u> to help them understand the suspension and permanent exclusion system in schools in England. The online guide is a comprehensive resource to help parents navigate the system should their child get suspended or permanently excluded. It also gives a list of organisations providing free advice and support.

### School Uniforms: guidance for schools

# **Updates to National Guidance**

### Home to school travel & transport: statutory guidance

The Department for Education previously consulted on revised statutory guidance for local authorities on home to school travel and transport for children of compulsory school age (5-16). Whilst there have been no changes in the law, the guidance was last updated in 2014.

The majority of responses received agreed that the revised guidance was clear and easy to understand, and would help local authorities to fulfil their school travel duties in relation to children of compulsory school age. However, there were a number of further improvements have suggested and these have been included in the revised statutory guidance published on 29 June 2023. These improvements include considering whether a parent can be expected to accompany their child, encouraging independence for children with disabilities and managing children's medical needs.

The policy for transport to post-16 education and training is different from that of children of compulsory school age, and as such is not included within this consultation. ### Senior mental health lead training

- The Department for Education (DfE) is offering a grant of £1,200 for eligible schools and colleges in England to train a senior mental health lead to develop and implement a whole school or college approach to mental health and wellbeing. This training is not compulsory, but it is part of the government's commitment to offer this training to all eligible schools and colleges by 2025.
- To be eligible you must be a state-funded school or college in England (including those in receipt of ESFA pre-16 revenue, high needs block, or 16 to 19 programme funding). Further information and a list of eligible setting types is available in the <u>conditions of</u> grant.

#### Behaviour case studies - use of behaviour hubs

### School inspection data summary report (IDSR) guide

- Ofsted's IDSR is now a web-based page showing data for Ofsted inspectors to use when preparing for and during inspection. The IDSR is designed to align with our <u>school inspection handbook</u>, so that areas of interest can be used to identify inspection trails.
- Ofsted have updated the IDSR for all schools, as well as the online IDSR guide. The guide, which gives an overview of the IDSR for primary and secondary schools and information to help interpret the charts, has been updated to include the 16 to 18 final 2022 data, including the updated retention measure. The trust / local authority level information section has also been updated to include the most recent inspection outcome (graded or ungraded) based on the latest URN for trusts only.
