## White British parent champion project

As part of Camden's focus on White British achievement, the 11 week 'Parent Champion' course concluded this week. Primary schools targeted and referred parents to the course,18 in total. Attendance was 96%. Outcomes included:



- an increased awareness of the issue of White British under-achievement, including barriers, and a desire to address this issue
- an awareness of the importance of parental engagement to support their child's learning
- a significant shift in ideas and aspirations for themselves and their children
- an commitment to continue to learn and to take risks in supporting their children's learning at home
- a change in language used with children at home e.g. 'positive' language
- a commitment to support other parents to participate in adult learning/parental engagement initiatives.

# Health and safety in science, design and technology

CLEAPSS, provide support for schools for practical science D&T and art. They have produced useful guides for schools on auditing in Science and D&T that will help schools ensure that departments are running effectively and safely. They



produced as well as documents that describe the most common hazards found when auditing so schools can ensure that labs and workshops are safe.

### Fire safety inspections

The London Fire Brigade (LFB) will be carrying out fire safety inspections across all of Camden schools over the next 12 months. In preparation for this inspection, schools should ensure that they have the following documentation in place, up to date and available on site for the fire safety officer to look at:



- 1) A fire risk assessment that has had been reviewed within the last year and updated to include progress a report on any recommendations made.
- 2) The school fire evacuation/emergency procedures.
- 3) Maintenance records relating to:
  - Fire alarm (servicing records and weekly call point test results)
  - Emergency lighting (monthly operational tests and annual discharge test)
  - Fire extinguishers (annual inspection report)
  - 5 year fixed mains wiring inspection report and details of any remedial works carried out
  - Lightning protection (if applicable)
  - · Portable appliance testing
  - · Fire door checks
  - Kitchen extraction ducting (if applicable)
- 4) Fire safety training records for staff (including kitchen staff if applicable)
- 5) Details and report of latest fire drills including time taken to evacuate (drills should be carried out termly)
- 6) Contractors signing in arrangements and information regarding fire procedures.

as an opportunity to review case studies in small groups and a Question & Answer session.


The workshop is aimed at Headteachers, School Business Managers/Bursars and other members of staff with line management responsibilities.
